RESOLUTION RATIFYING THE SHELBY COUNTY COMPREHENSIVE GROWTH PLAN AS APPROVED BY THE SHELBY COUNTY COORDINATING COMMITTEE ON DECEMBER 22, 1999 PURSUANT TO TENNESSEE PUBLIC CHAPTER 1101 OF 1998

WHEREAS, Public Chapter 1101 provides the structure and processes for local governments to cooperatively determine their own growth plan and provide sufficient flexibility to allow local governments to tailor growth plans to suit the unique character of their areas; and

WHEREAS, Tenn. Code Ann. §6-58-104(a)(2) provides that it is the duty of the Coordinating Committee to develop a recommended growth plan which identifies urban growth boundaries of each municipality in the county and planned growth areas and rural areas within the county; and

WHEREAS, Shelby County Government and the City of Memphis, along with the City of Bartlett, City of Germantown, City of Lakeland, City of Millington, Town of Arlington and Town of Collierville agreed to the terms and conditions of a Memorandum of Understanding pertaining to issues of annexation, allocation of certain sales tax revenue, and sharing of certain funding and service obligations, as well as growth planning for the good of all citizens of Shelby County; and


WHEREAS, Said Memorandum which was approved by the Board of County Commissioners on September 27, 1999, provided the basis and framework for Shelby County Government and the municipalities to establish the Shelby County Growth Plan pursuant to Public Chapter 1101; and

WHEREAS, the Shelby County Coordinating Committee, pursuant to Public Chapter 1101, approved the Shelby County Comprehensive Growth Plan on December 22, 1999; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF SHELBY COUNTY, TENNESSEE, That the Shelby County Comprehensive Growth Plan as approved by the Shelby County Coordinating Committee on December 22, 1999, attached as Exhibit A and incorporated by reference, is hereby ratified and approved.



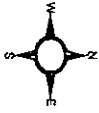
