- ¹ All items that require LUCB review, including correspondence cases, plus minor subdivisions.
- ² See UDC Sec. 9.3.2 for items that require a neighborhood meeting.
- ³ Not required for all applications. If determined by OPD Staff that an application requires review by the Technical Review Committee, OPD will contact the applicant and their representative to request their appearance at the TRC Meeting See UDC Section 9.1.8B for optional and mandatory applications to go before the TRC.
- ⁴ Unless otherwise announced. Executive Session is held in Conf. Room A on the fourth floor of City Hall, 125 N. Main.
- ⁵ Applications for Minor COAs may be filed at any time throughout the month and do not require review by the Landmarks Commission. However, upon review by staff, some of these applications may require their conversion to a Major COA and added to the next available Landmarks Commission agenda. These conversion deadlines mark the last date that a Minor COA may be converted to a Major COA. All materials for these conversions, including mailing labels, must be received by 4:00 on the conversion deadline.
