A total of \$169,567.00.00 was awarded under this bid package and was awarded to five contractors.

The basis for this recommendation is as follows:

4271 Rippling Brook Cv:	Bond submitted the lowest bid for this job, but the specifications contained an error. The specifications will be corrected and the job will be rebid.
5040 Blacksmith:	Coleman submitted the lowest acceptable bid for this job.
2490 Arlington:	FC submitted the lowest acceptable bid for this job.
665 Davant:	ELS submitted the lowest acceptable bid for this job.
1477 Merton:	ETS submitted the lowest acceptable bid for this job.
2364 Peres:	ETS submitted the lowest acceptable bid for this job.
767 Raines:	The bid from ELS exceeded the acceptable cost range based on the department's internal cost estimate. This job will be rebid.
1399 Raymond:	Bond submitted the lowest acceptable bid for this job.
1797 Tahiti:	No bids were received for this job.
566 Walker:	ETS submitted the lowest acceptable bid for this job.
799 Watkins:	FC submitted the lowest acceptable bid for this job but there was a math error between the line item total and the total bid amount. FC reject the award and the next lowest bid exceeded the acceptable cost range based on the department's internal cost estimate. This job will be rebid.
1499 Willett:	ETS submitted the lowest acceptable bid for this job.


