- 2 See UDC Sec. 9.3.2 for items that require a neighborhood meeting.
- 3 Not required for all applications. If determined by DPD Staff that an application requires review by the Technical Review Committee, DPD will contact the applicant and their representative to request their appearance at the TRC Meeting. See UDC Section 9.1.8B for optional and mandatory applications to go before the TRC.
- 4 Design Review Meeting will be held on Wednesday, April 5th for April 2023 Landmarks Commission cases.
- 5 Design Review Meeting will be held on Wednesday, July 5th for July 2023 Landmarks Commission cases.
- 6 The LUCB meeting on September 14th will be held in City Hall, 5th Floor Conference Room.
